2. INSTRUCTIONAL SERVICES--BOARD DISCUSSION AND/ OR ACTION (The Board may take action on any item in this section, unless it is designated for information only.)

2.01 Public Hearing on Proposed Amendments to Board Policy 6158 - Independent Studies Program (Education Code section 51747 and 5 CCR section 11701).

2.02 Waive Second-Reading requirement (per Board Bylaw 9310) and Approve Amended Board Policy 6158 – Independent Study.Assembly Bill 130 signed by Gov. Newsom into law on July 9, 2021, imposes new independent studies options and requirements on public school districts. AB 130 requires that the Governing Board adopt policies implementing the new statutory requirements. Per Board Bylaw 9310, Board Policies are typically reviewed and adopted through a two-reading process. Board Bylaw 9310 also provides, however, that "[t]he Board may waive the second reading or may require an additional reading if necessary." Because of the need to adopt the policy changes immediately, in advance of the new school year, and to inform the parents of the independent studies options and requirements right away, the Board is requested to waive the second-reading requirement per Bylaw 9310 and to approve Amended Board Policy 6158 as presented.

2.03 Waive Second-Reading requirement (per Board Bylaw 9310) and Approve Amended Board Policy 5123 – Promotion/Acceleration/Retention Assembly Bill 104 signed by Gov. Newsom into law on July 1, 2021, imposes new options for parents and requirements on public school districts relating to retention of students in their last grade level, including notifications to parents of their rights and opportunities under the new law. Per Board Bylaw 9310, Board Policies are typically reviewed and adopted through a two-reading process. Board Bylaw 9310 also provides, however, that "[t]he Board may waive the second reading or may require an additional reading if necessary." Because of the need to adopt the policy changes immediately, in advance of the new school year, and to inform the parents of the options they may wish to consider for their students, the Board is requested to waive the second-reading requirement per Bylaw 9310 and to approve Amended Board Policy 5123 as presented.
