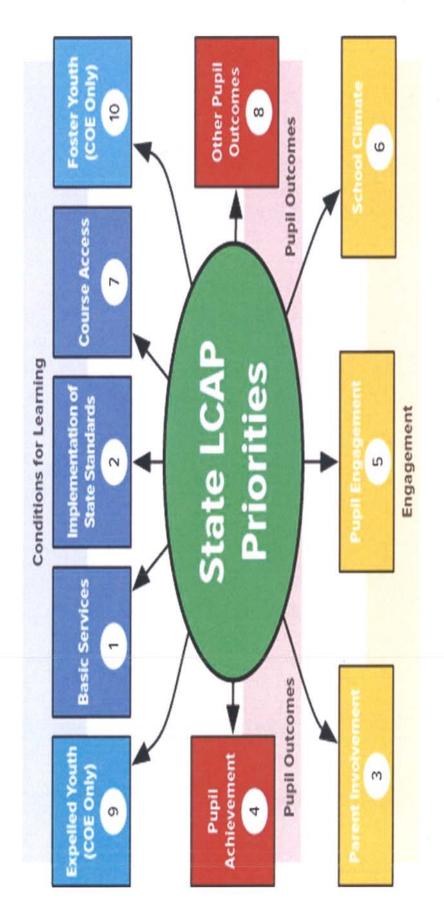

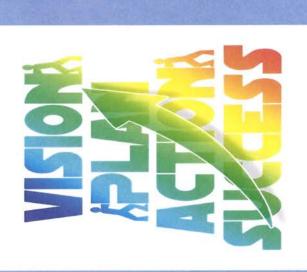

Staff Analysis:

On February 11, 2021, the Board approved one-time, off-schedule payments of \$2,000 for 2019-2020 and \$2,000 for 2020-2021 for AREA bargaining unit members. CSEA and Teamsters members are entitled to the same one-time, off-schedule payments per contract terms. District Administration is recommending that all Unrepresented Personnel (Confidential, Supervisory, Classified Management and Certificated Management) receive the same one-time, off-schedule payments of \$2,000 for 2019-2020 and \$2,000 for 2020-2021.

Resolution of the Board of Alum Rock Union School District to Denounce Hate Crimes and Rhetoric Against Asian Americans and Pacific Islanders, and Reaffirm Our Commitment To Ensure API Americans Feel Safe and Welcome

Resolution # 34-20/21

WHEREAS, The Asian Pacific Policy and Planning Council and Chinese for Affirmative Action launched a hate incident-reporting internet website, "Stop AAPI Hate," at the beginning of the COVID-19 outbreak in March of 2020; and

WHEREAS, The Stop AAPI Hate Reporting Center reported over 2,800 hate incidents against Asian Pacific Islander (API) Americans in 2020; and

WHEREAS, Discrimination and racism towards APIs has always existed, such as the 19th century scapegoating of APIs, also known as "Yellow Peril"; and

WHEREAS, Racism, hate crimes and negative rhetoric towards APIs has been exacerbated by the COVID-19 pandemic; and

WHEREAS, Politically charged and culturally insensitive language referring to COVID-19 as the "Chinese virus" or "kung flu" further encouraged racism, prejudice and hate crimes towards APIs; and

WHEREAS, The promotion of such language by the former President Donald Trump during his term further propagated anti-API sentiment in light of COVID-19; and

WHEREAS, On January 31, 2021, three elderly Asian Americans were assaulted in the City of Oakland's Chinatown District, including a 91-year-old Asian man who sustained serious injuries, such as lacerations, abrasions, and a contusion to the left thumb, in what is deemed a hate crime; and

WHEREAS, On January 30, 2021, 84-year-old Vicha Ratanapakdee, a nearly-blind and gentle elderly Thai man, died from injuries resulting from an attack while he was walking in the City of San Francisco, in what is deemed as a hate crime; and

WHEREAS, About 31 percent of Asian Americans report having been subject to discrimination since the beginning of the COVID-19 pandemic, according to a Pew Research Center report; and

WHEREAS, Asian Americans in the State of California are increasingly concerned about their safety and well-being, given the rise of hate crimes and other racially motivated attacks; and

WHEREAS, Asian Americans in the State of California are more concerned about the safety of themselves and their families that are currently at high risk of being targeted; and

WHEREAS, In 2020, the California State Legislature's API Legislative Caucus spoke out against anti-API hate crimes in an effort to stand up for immigrant and refugee individuals; and

NOW, THEREFORE BE IT RESOLVED, that the Alum Rock Union School District, on behalf of district all residents thereof, denounce hate crimes, hateful rhetoric and hateful acts against Asian Americans and Pacific Islanders, and reaffirm our commitment to ensure that API Americans feel safe and welcome, both during this COVID-19 pandemic and beyond; and **FURTHER BE IT RESOLVED,** that the Clerk of the Board of Alum Rock Union School District transmit copies of this resolution to Governor Gavin Newsom, U.S. Senators Alex Padilla and Dianne Feinstein, Congressmember Zoe Lofgren, State Senator Dave Cortese, State Assemblymember Ash Kalra.

RESOLUTION OF THE BOARD OF EDUCATION OF THE ALUM ROCK UNION ELEMENTARY SCHOOL DISTRICT TO PROMOTE A STRONG ECONOMY AND GOOD PAYING JOBS IN THE ALUM ROCK COMMUNITY AND ESTABLISHING A LOCAL BUSINESS AND HIRING PREFERENCE PROGRAM

RESOLUTION #35-20/21

WHEREAS, the Alum Rock School Elementary School District (the "District") serves more than 8,000 children in grades K-8 in 24 schools located throughout the District with an operating budget of more than \$100,000,000 annually;

WHEREAS, the District community includes more than over one hundred thousand residents in households, spanning across 3 San José City Council districts and 2 county supervisorial districts

WHEREAS, according to data published by the U.S. Census Bureau in its American Community Survey (2018), more than 10% of all children in the District live in "deep poverty", that is, they live in situations with incomes below 50% of the local applicable federal poverty threshold;

WHEREAS, according to data published by the U.S. Census Bureau in its American Community Survey (2018), the median family income of families with children in the District is less than 50% of the median family income of families throughout Santa Clara County;

WHEREAS, according to the U.S. Census Bureau in its American Community Survey (2018), 37% of all children in the District lacked a resident parent who worked at least 35 hours per week for the previous 50 weeks in the previous year;

WHEREAS, the District's voters have previously passed bond measures authorizing the issuance of more than \$140,000,000 in bonds for school construction, modernization and renovation;

WHEREAS, repayment of the bonds, once issued, is secured by the levy of ad valorem taxes on property within a district and thus paid for by residents and property owners of the District;

WHEREAS, the District has a proprietary interest in leveraging, to the greatest extent possible, the dollars it spends contracting with private firms for goods, equipment and services to create benefits and opportunities for the District and its community and residents;

WHEREAS, The District has a proprietary interest in leveling the playing field among those entities competing for District contracts, to assure the greatest level of competition possible, to decrease local unemployment, and to increase District revenues; WHEREAS, significant benefits are associated with a local business preference program, including an increase in local jobs, increased training opportunities for residents of the District community, and an increase expenditures in the local private sector and in local businesses and rising real estate values.

WHEREAS, preference programs in other jurisdictions have been successful where the business conditions approximate the conditions currently being experienced in the District community and greater east San Jose. For example, both the City of San José and Santa Clara County each have local preference procurement programs.

WHEREAS, the California Government Code, sections 4217.10 - 4217.18, provides that a public agency may enter into an energy service contract and any necessarily related facility ground lease on terms that its governing body determines are in the best interests of the public agency if the determination is made at a regularly scheduled public hearing, public notice of which is given at least two weeks in advance, and if the governing body finds that, (1) that the anticipated cost to the public agency for thermal or electrical energy or conservation services provided by the energy conservation facility under the contract will be less than the anticipated marginal cost to the public agency of thermal, electrical, or other energy that would have been consumed by the public agency in the absence of those purchases, and (2) that the difference, if any, between the fair rental value for the real property subject to the facility ground lease and the agreed rent, is anticipated to be offset by below-market energy purchases or other benefits provided under the energy service contract.

WHEREAS, the Board of Trustees desires to establish a preference for local businesses in connection with any energy service contracts that the Board may approve.

NOW THEREFORE BE IT RESOLVED THAT, the Board of Education of the Alum Rock Union Elementary School District does hereby resolve that all energy service contacts approved by the Board of Trustees and entered into by the District in accordance with Government Code sections 4217.10 - 4217.18 shall include that not less than **twenty five percent (25%)** of the labor employed or contracted to perform the project work (including subcontracted and subsubcontracted labor) shall be persons residing within or surrounding the territorial jurisdiction of the District, including persons residing in the 95116, 95122, 95127, 95132, 95133, and 95148 zip codes in Santa Clara County.

BE IT FURTHER RESOLVED, that each contractor and subcontractor performing work on the project shall pay to all workers performing such work at least the prevailing rate of wages, as defined in Article 2 (commencing with Section 1770) of Chapter 1 of Part 7 of Division 2 of the California Labor Code.

BE IT FURTHER RESOLVED, that each contractor and subcontractor performing work on the project shall use a skilled and trained workforce, as defined in Chapter 2.9 (commencing with Section 2600) of Part 1 of Division 2 of the California Public Contract Code. BE IT FURTHER RESOLVED, that each contractor and subcontractor performing work on the project shall hire apprentices from state-approved programs to perform at least the same ratio of hours of work that would be required on a public works project by California Labor Code Section 1777.5 and the regulations of the California Apprenticeship Council.

BE IT FURTHER RESOLVED, that all electrical work on the project will be performed by contractors and subcontractors that hold Class C-10 electrical contractor licenses and that will use certified electricians to perform the work in accordance with California Labor Code Sections 108-108.5

BE IT FURTHER RESOLVED, that the District Administration is hereby directed to inform all staff and prospective vendors and contractors of the District by, among other things, including these terms in all requests for proposals and/or requests for qualification for energy service contracts (per Government Code 4217.10 - 4217.18), and into Board Policy and applicable administrative regulation(s).

Subject: Second Interim Financial Report

Staff Analysis: The Second Interim Report is one measure designed to help the County and ultimately the State to monitor each school district's fiscal health. According to the State requirements, in order to have a Positive Certification, ARUSD must project at least 3% in unrestricted reserves in each of the current and following two years. Districts that may not meet this requirement receive a gualified budget certification and Districts that do not demonstrate that they will meet this requirement receive a negative budget certification. If any problems are anticipated, the County will offer immediate fiscal management advisory services.

> School districts in California are required to maintain their financial affairs in accordance with prudent financial management principles. Those principles were strengthened and codified in 1991 with the passage of AB 1200. The increased oversight provided by AB 1200 was in response to a number of school district nearbankruptcies, requests for state loans, and defaults on school district financial obligations.

> The statute requires school districts to self-certify budgets, interim reports, unaudited actuals, and disclosure statements related to collective bargaining. The law also requires county offices of education (COE) to review the various certifications and determine whether the financial position of the district is in conformance with staterecommended standards and criteria. The COE is empowered to initiate action if problems are disclosed or discovered. That action may take the form of additional questions or warnings, a lowering of the self-rating from "positive" to either "qualified" or "negative," appointment of a fiscal advisor, or more stringent measures if the situation warrants.

> The Alum Rock Union Elementary School District is presenting a Qualified Certification of its financial condition. This means that the District may not meet its financial obligations for the current fiscal year or two subsequent fiscal years.

RESOLUTION TO CONFIRM ALUM ROCK UNION ELEMENTARY SCHOOL DISTRICT'S COMMITMENT TO FISCAL SOLVENCY

WHEREAS, the Board of Trustees of the Alum Rock Union Elementary School District has a fiduciary duty to meet its financial obligations in the current fiscal year and two subsequent fiscal years pursuant to Education Code 42127 and is currently in qualified status;

WHEREAS, the Alum Rock Union Elementary School District recognizes that the 2014 Measure O voter-approved parcel tax will expire at the end of fiscal year 2021-22, and if not extended by voters of the Alum Rock community, that will result in on-going revenue reduction of approximately \$4.5M per year;

WHEREAS, included in the District's current budget is one-time Federal funds to address the COVID-19 pandemic of approximately \$14 million and \$10 million in 2020-21 and 2021-22, respectively;

WHEREAS, the Board of Trustees of the Alum Rock Union Elementary School District recognizes the district has a significant structural deficit that must be resolved. In 2020-21 and 2021-22, there is an infusion of one time dollars from the state and federal government to address COVID-19 related expenditures and the impact of declining enrollment has been temporarily mitigated because of COVID-19 related measures, but in 2022-23 the district faces a structural deficit as noted in the second interim report of \$14.5 M (unrestricted income less unrestricted expenditures);

WHEREAS, the Alum Rock Union Elementary School District has a Certificate of Participation debt repayment of approximately \$2.3M per year, with identified funding sources through 2021-22, and that starting in fiscal year 2022-23 the repayment plan provides for the remaining \$8.5M in debt to paid from unissued Measure I bond proceeds or it will otherwise become an obligation of the Unrestricted General Fund;

NOW THEREFORE BE IT RESOLVED, based on the above recitals and in order to ensure that the Alum Rock Union Elementary School District remains fiscally solvent, the Board of Trustees is committed to reducing expenditures in all budget areas including total staffing, benefits, services and operating

expenses, capital outlay, and other outgoing, and is also committed to examining potential sources of revenue, including but not limited to the repurposing of excess facilities to generate facilities use or leasing revenue. The Board of Trustees is committed to taking appropriate action to begin addressing these projected funding shortfalls with the adoption of the 2021-22 budget in June 2021.

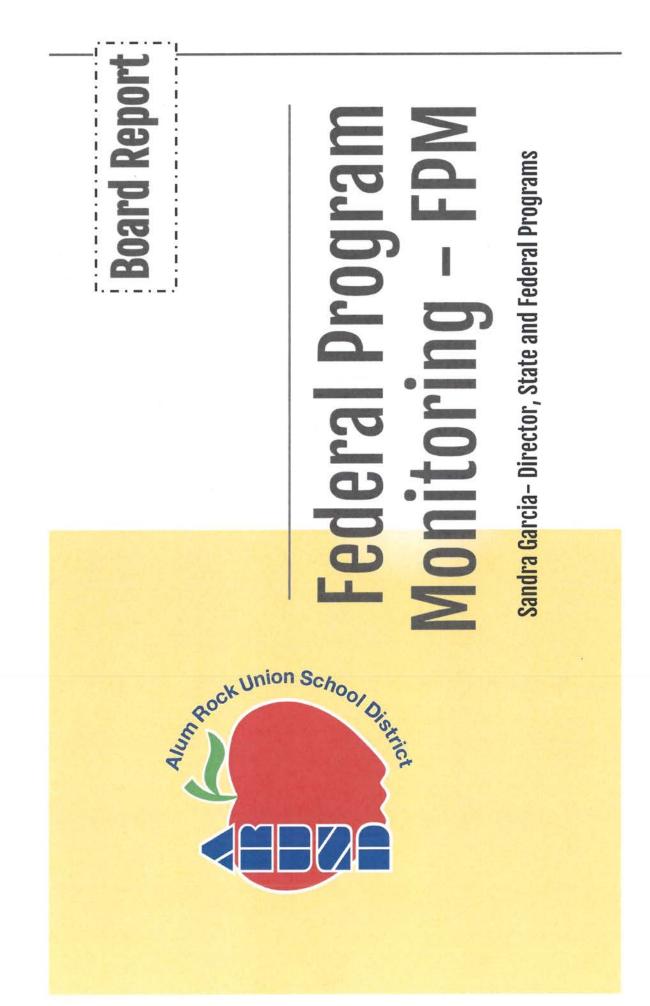

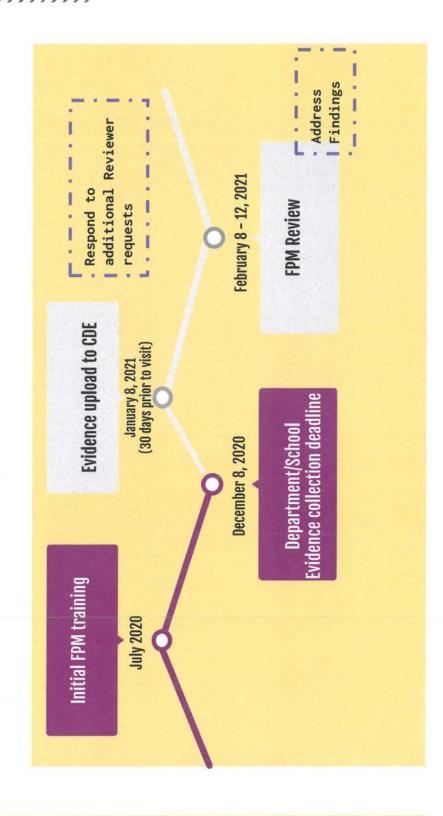

FPM TIMELINE



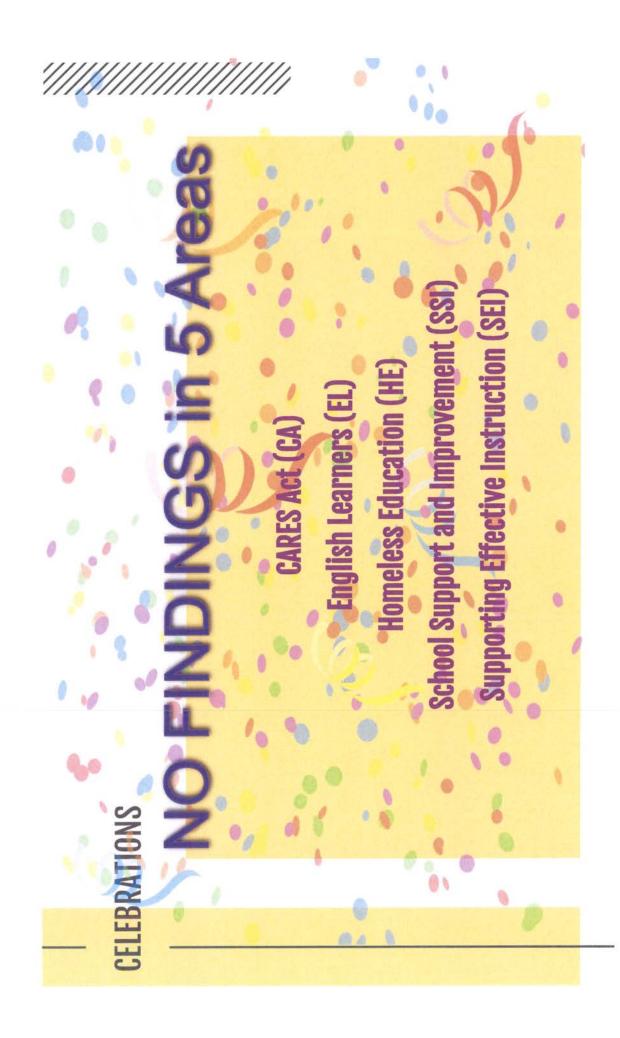

The following agreement will be incorporated in the 2020-2023 successor agreement that is currently being negotiated.

ARTICLE VIII

PAY AND ALLOWANCE

8.1 Regular Rate of Pay.

8.1.1 For the 2020-2021 school year:

Effective July 1, 2020, CSEA unit members shall receive a 0% (zero percent) increase to the salary schedule.

CSEA unit members employed during the 2020-2021 school year shall receive a onetime, off-schedule payment of \$2,000 (two thousand dollars). CSEA members who were not employed full time shall have this amount pro-rated (*).

*CSEA bargaining unit members with a 0.75 FTE (Full-Time Equivalent) or higher shall receive one-time, off-schedule payment of \$2,000 (two thousand dollars). Bargaining members with less than a 0.75 FTE (Full-Time Equivalent), or members who worked a portion of the year, shall be paid the \$2,000 off schedule payment on a pro-rated basis. This one-time payment applies to any bargaining unit members in paid status during the 2020-2021 school year.

- 8.1.2 For the term of this Agreement, if any other bargaining unit receives a salary schedule increase, off-schedule bonus or health and welfare premium increase or reopener(s) greater than the CSEA bargaining unit, the CSEA shall receive the same increase.
- 8.1.3 For year three of this Agreement, the parties shall negotiate salary.

For the term of this agreement, if any other bargaining unit receives a salary schedule increase, off schedule bonus or health and welfare premium increase or reopener(s) greater than the CSEA bargaining unit, the CSEA shall receive the same increase.

Once Ratified, CSEA members will receive \$2,000 onc-time, off-schedule payment on April 10, 2021.

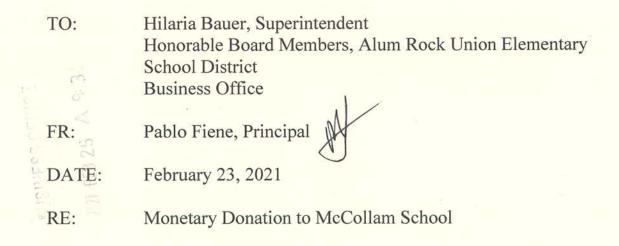
