SCHOOL PROFILE

SETTING

Located in the East San Jose Foothills, Linda Vista School is one of twenty elementary schools in the Alum Rock Union Elementary School District and serves approximately 689 students in grades K-5. The school is in a residential area surrounded by three churches. Businesses close to the school on McKee Road include a supermarket, several restaurants, and other small businesses. Most Linda Vista students walk or are driven to school by parents.

DEMOGRAPHIC DATA

Linda Vista students represent a diverse cultural population, Hispanic being the predominant group. Eleven languages are spoken in the community, and more than 45.3% of Linda Vista students are English Language Learners. Demographic data from the 2007-2008 Academic Performance Index (API) Growth Report show that 70.5% of our families are eligible for the free and reduced breakfast and lunch program. At the beginning of the school year, the teachers, literacy coach, School Leadership Team, School Site Council, and English Learner Advisory Committee met to address concerns and to develop a school action plan to improve teaching and academic achievement. The administration and teachers concluded that the grade levels must use assessment results to evaluate the instructional programs and to target areas for improvement. The literacy coach will collaborate with each grade level to ensure that teachers are varying their instructional strategies to better assist English Language Learners and under-performing students. The grade levels will also work on translating the content standards into language students understand so they know what they are expected to produce. Staff and parents also determined that more emphasis should be placed on parent involvement and parent awareness of classroom instructional goals. Teachers will provide family workshops on building literacy and math skills at home. Community-Based English Tutoring classes will also be offered

SPECIAL EDUCATION, ELL, GATE, AND TARGETED ASSISTANCE DATA

Linda Vista School has two Special Day Classes: one A.M. SDC Kindergarten, and one SDC class for grades 3-5. Regularly scheduled Student Study Team meetings are held to address the needs of under-achieving students, and I.E.P.s are updated to provide services to Special Education students. There are four pullout programs that support students with special needs in grades K-5: Resource Specialist Program, Occupational Therapist, Adapted Physical Education and Speech Therapy. Gifted and Talented Education students are provided with daily, differentiated instruction for fifty minutes during the regular school day and participate in enrichment programs after school. English Language Learners (ELL) in grades 1-5 receive forty-five minutes of English Language Development (ELD) instruction each day. ELL kindergarten students receive 30 minutes of ELD instruction every day. ELL students classified as Level 1 and Level 2 on the California English Language Development Test receive additional support from a bilingual paraeducator.

LINDA VISTA SCHOOL LIBRARY

More than 600 students visit the library. Students in grades K-5 visit the library bi-monthly. There are four computers available for student use. Parents and staff also check out books and other materials. An automated circulation and cataloguing system has been implemented.

The SSC, ELAC, and the PTA meet monthly and are integral to discussions and decisions made on a variety of school issues such as budget, school-wide activities, and special projects.

EARLY CHILDHOOD PROGRAM

The Kidango daycare program is housed on an adjoining campus. Since we share students, the Kidango director has given an in-depth presentation to the Linda Vista teachers on their programs and services. Kidango students are allowed to attend after school interventions and the Homework Center on the Linda Vista campus. In addition, Linda Vista teachers participate in a continuing dialogue with the Kidango staff to address critical topics related to student learning and academic goals. In order to support early literacy skills in pre-kindergarten aged children, the Linda Vista Library Assistant has implemented a monthly story time.

TECHNOLOGY

Linda Vista staff will, with the support of district staff, continue to implement integration of technology into the curriculum as an additional way to increase student achievement. The connectivity to the internet has been recently improved with upgrading of communication lines into and between the buildings. Use of programs like United Streaming can be extremely beneficial when used as part of the staff's teaching strategies. Every teacher will also have access to "Cruncher" a web based program that disaggregates student scores and data on CELDT and STAR tests which then can be used as an aid in the improvement of instruction. Students will also benefit by being able to improve their computer skills through word processing and doing research on the internet.

Goals

As expressed in the Single School Plan, Linda Vista's goals are:

- As part of the AYP target, 35.2% of students in grades K-5 will achieve the performance level of proficient/advanced on the California Standards Test in English/Language Arts.
- As part of the AYP target, 37.0% of students in grades k-5 will achieve the performance level of proficient/advanced on the California Standards Test in Mathematics.
- All English Learners will increase two proficiency levels for students at proficiency level 1 and one proficiency level for students at proficiency levels 2-5 in one year's time as evidence on the annual CELDT.

Progress Monitoring

Linda Vista has adopted a data-driven cycle of inquiry approach to school improvement that impacts budget, curriculum, instruction, assessment, and student achievement and is implementing data-driven instruction by making data readily available to all teachers. Since the current data system is cumbersome and difficult to access, the District invested in a data management system, called the "Cruncher". Easily accessible and simple to use, the "Cruncher" allows teachers to access their students' performance data so that they can compare it to school-wide, district, state and national data to ascertain student performance and guide their efforts to individualize instruction, provide differentiated instruction that is responsive to the students' assessed needs and measure the effectiveness of their own instruction. The Cruncher also allows administrators to assess the effectiveness of curriculum and support intervention programs. In addition, Cruncher information regarding criterion-referenced test performance (STAR, CELDT, etc.), district assessments, and writing samples, suspension, referral, and attendance data, student work samples, authentic assessment data from project-based, inquiry-based, work-based, open-ended, and portfolio assignments, qualitative data to ascertain stakeholder satisfaction, and observations of student performance are used to measure whether all students are meeting the

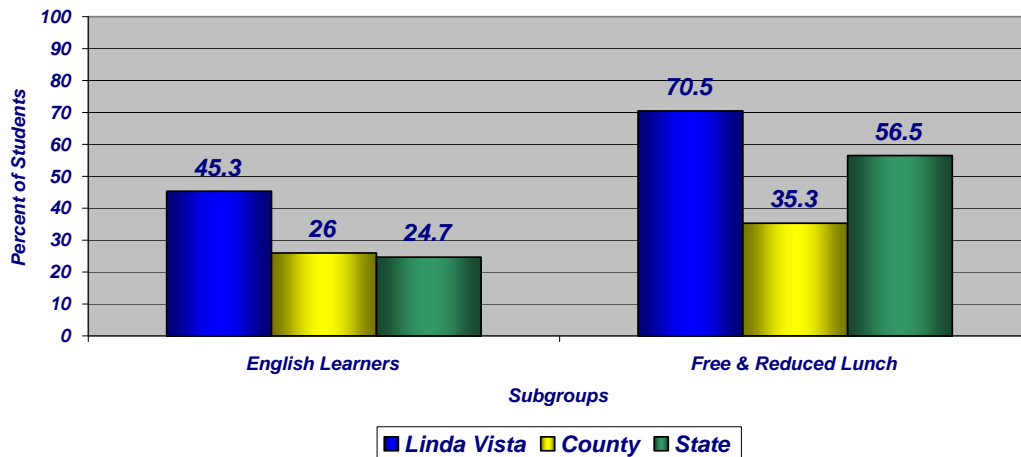

The District makes every effort to ensure that all schools are clean, safe, and functional. To assist in this effort, the district uses a facility survey instrument developed by the State of California Office of Public School Construction. The results of this survey are available at the school office and at the district office. School facilities were constructed and are being renovated according to the Field Act requirements of the State Building Code that is heavily focused on earthquake safety. In the event that asbestos and lead containing building materials are found, they are managed and removed according to EPA and State and local requirements. Deferred maintenance funds have been used to properly maintain and renovate district buildings. Needed repairs and maintenance projected are completed in a timely manner.

School facilities are upgraded whenever possible to support and maintain a safe, clean and secure campus. Sufficient classroom, office, library, playground, staff space, and restroom facilities are allocated to support stakeholders' needs and the instructional program. The Alum Rock School District Maintenance and Grounds staff, in conjunction with day and night custodians, ensures the school buildings and grounds are safe, clean, and in good repair. Rigorous daily custodial schedules ensure that classrooms, lavatories, serving kitchens, eating areas, offices, and playgrounds are clean for both student and staff use. Regular oversight by district maintenance and grounds crews ensure that grass and landscaped areas are well maintained and that the school's buildings, grounds and play areas are safe for use.

All visitors are required to check-in at the school office. Fire drills and disaster procedures are specifically outlined and regularly updated and practiced. Safety programs include drug awareness, personal safety, and personal growth. To ensure a safe environment, the district provides extra yard duty supervisors, and all yard duty supervisors and school staff maintain a welcoming but controlled campus environment. The school grounds and playground are safe because they well-supervised by staff before, during, and after school.

Age of School Buildings

Although the main school campus was constructed in 1950, portable buildings have been added to accommodate the growing school population and diverse program needs.

Maintenance and Repair

District maintenance and facilities staff to ensure that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority.

Cleaning Process and Schedule

The district's Board of Trustees has adopted cleaning standards for all schools in the district. The Leadership Team works daily with the custodial staff to maintain cleaning schedules to ensure a clean and safe school.

Deferred Maintenance Budget

The district participates in the State School Deferred Maintenance Program, which provides state matching funds on a dollar-for-dollar basis, to assist school districts with expenditures for major repair or replacement of existing school building components. Typically, this includes roofing, plumbing, heating, air conditioning, electrical systems, interior or exterior painting, and floors systems.

Modernization Projects

During the 2007-2008 school year, local Measure A funds and state-matching funds were used to renovate

Professional staff development is provided in differentiated instructional strategies in reading, math language arts and ELD. The intervention programs are:

- Before/after school classes in language arts, reading, and mathematics in grades K-5
- Saturday Academies for grades 2-5
- Before/after school Homework Center in grades 1-5
- Daily independent workshop time when teachers work with individual and small groups of students for thirty to forty minutes, using the Intervention Guides or the Reteach sections of Open Court
- Flexible instructional grouping of ELD, GATE, and under-performing students to allow for remediation and enrichment for a fifty minute block of time on a daily basis
- Testwiseness program to teach students test-taking strategies
- Literacy coach to support reading comprehension and fluency instruction
- Extended school year for K-1 students

**XII. Instructional Planning and Scheduling
Professional Development**

This section provides information on the annual number of school days dedicated to staff development for the most recent three-year period.

Professional development opportunities for staff members are multifaceted and clearly and consistently linked to the state's standards and the school's core values. Professional development is driven by student data and directly linked to teaching and learning. All professional development opportunities are personalized to address the needs of all teachers, staff, and administrators. Not only do professional development activities for teachers reflect a best practices approach, but they also align with the California Standards for the Teaching Profession. Teachers and staff participate in professional development that is aligned with their individual needs at multiple levels. At the school level, professional development is structured to have a generalized focus (e.g., standards-based instruction), and specific facets of the professional development program (e.g., specific instructional strategies) are personalized to address the specific content area dynamics and needs. The district also offers a multitude of professional development opportunities and teachers have multiple opportunities to select from a menu of ongoing staff development opportunities to broaden their knowledge, enhance their classroom management skills, and learning support strategies. Teachers have multiple opportunities to participate in District workshops; attend conferences; participate in District-sponsored new teacher workshops on classroom management, teaching and learning, etc.; in the Beginning Teacher Support and Assessment Program (BTSA); Peer Assistance and Review (PAR); and many literacy and teaching and learning seminars. In addition, many teachers take professional growth classes at local colleges and universities and attend workshops offered by the Santa Clara County Office of Education. Teacher selection for paid professional development activities is predicated on the value of the activity to identified student learning needs, teacher needs (based on assignment and performance data), and resource availability. To ensure that all school staff have the same opportunities for ongoing learning, the district offers classified staff a number of professional development activities that are designed to address their individual job descriptions. For example, classes are offered in Excel, eSchoolPlus, and other computer applications; safety and organizational maintenance; landscaping; and computer maintenance and repair. Similarly, administrators are offered ongoing professional development through their monthly meetings, professional organizations (Association of California School Administrators), and conferences.

To ensure that professional development opportunities are effective, teachers and administrators regularly analyze data and use their findings to inform decisions regarding teaching and learning, use of time, and overall professional development program integrity. To support teachers to implement new strategies, the site administrator makes frequent classroom visits and provides timely feedback to increase instructional effectiveness. In addition, the district employs literacy and math coaches who are available to work with teachers in developing and implementing appropriate and innovative instructional strategies that are aligned with the California Standards, are infused with higher level thinking skills, and are differentiated to accommodate the needs of all students.

Because teachers share "best practices", work towards common goals, collaboration and collegiality permeate the school culture. Consequently, teachers, as a group, realize the need to reach consensus about curriculum, instruction, discipline, teacher and program evaluation, and school operations. School wide and grade-level meetings are held routinely so that teachers can continue to work on professional development to support school-wide efforts to align curriculum with rigorous state content standards as well as to provide instructional support for literacy and differentiation to assure the achievement of all students. In addition to collaborating with their peers, our teachers also collaborate with middle schools to articulate curricula, gather data on student performance with which to refine the instructional program, share best practices, and gain new perspectives.
